PURPOSE OF THE ROLE
CSA has a dedicated and passionate team of employees, co-workers and short-term volunteers, based across three campus sites approximately 6 miles west of Aberdeen City. A vacancy has arisen within the CSA Land Team for an enthusiastic and capable Estate Maintenance Worker to join the Land Team. This role may involve occasionally working with young people with additional support needs, and the successful candidate will work with the wider CSA community to provide meaningful opportunities and workplace activities. The Estate Maintenance Worker will care for all aspects of the estate across the campuses of CSA including the Care Farm and Gardens and will be based at Murtle Estate, Bieldside, Aberdeen. Estate maintenance experience is required; however, training and support will be available to the right person.
KEY TASKS

Ensure that all work meets health and safety requirements according to current regulations and CSA policies and that facilities and equipment are correctly maintained.3. Support with winter maintenance and be available for weekend work at times.4. Engage with the wider CSA Facilities Team.

EXPERIENCE

Required:

- 1 year's relevant experience of estate maintenance work.
- Knowledge of horticulture e.g., lawn, tree bush and brush care.
- Use of estate maintenance machinery and hand tools e.g., sit on mower, push mower, leaf blower, hedge trimmer and brush cutter, snow and ice clearing equipment.
- Demonstrable interest in working with Organic practices and sustainability.
- A commitment to engaging with children and young adults with additional support needs, the service, their key staff, the care farm and estate staff and the wider community
- Ability to work in a positive supportive working environment as part of a small team.
- Ability to be self-reliant, able to work individually and use own initiative.
- Physically fit and able to carry out manual tasks.
- Willing to undertake seasonal garden maintenance duties e.g., grass cutting, strimming and weeding.
- Willing to undertake winter maintenance duties e.g., snow and ice clearing and gritting.
- Willing to work on weekends, early mornings and evenings when required.
- Excellent communication skills
- Excellent organisational skills and able to prioritise own work.
- Hold a valid driver's licence (subject to DVLA check)

Desirable:

- Experience of working with people with additional support needs.
- NVQ level II or equivalent in a relevant subject area such as estate maintenance or horticulture.
- Experience with Organic practices.
- Experience of driving agriculture machinery such as tractors
